**OPTION #1:**

You may decide not to contest the citation and pay the civil penalty indicated in the NOTICE portion of the citation form by mail, or in person, within seven (7) days from the date of issuance.

**OPTION #2:**

**FINDINGS OF FACT, CONCLUSIONS OF LAW AND FINAL ORDER**

The Respondent, WILLIE E. TAYLOR (ESTATE) C/O ANNA TAYLOR, being properly notified of the violation(s) on property located at, 918 HAYES ST, HOPKINSVILLE, KY 42240, and failing to exercise his/her rights as contained in section KRS 65.8825(6), Findings of Fact, Conclusions of Law and Final Order- are issued as follows:

**FINDINGS OF FACT**

The Respondent, WILLIE E. TAYLOR (ESTATE) C/O ANNA TAYLOR is the owner or person in charge of property located at 918 HAYES ST, HOPKINSVILLE, KY 42240.

The Respondent was issued a citation by MIKE GUESS, Code Enforcement Officer, dated February 10, 2017 which charged the Respondent with a violation of Chapter 158.0 of the City of Hopkinsville, Kentucky Code of Ordinances, described as follows: Auto Repair in Residential Zone.

The Respondent failed to respond to said citation within seven (7) days as required by KRS 65.8825(6) and the Hopkinsville Code of Ordinances, Chapter 133.188(F).

It is found that the condition described in the citation did, in fact, exist at the time the citation was issued, and that the condition was caused by the Respondent, or was the responsibility of the Respondent, as owner or person in charge of the property on which the violation occurred.

**CONCLUSIONS OF LAW**

It is concluded, based on the foregoing Findings of Fact, that Respondent, WILLIE E. TAYLOR (ESTATE) C/O ANNA TAYLOR has committed a violation of Chapter 158.0 of the City of Hopkinsville, Kentucky Code of Ordinances, as charged in the citation.

**FINAL ORDER**

Respondent, WILLIE E. TAYLOR (ESTATE) C/O ANNA TAYLOR, is ordered to pay \$100.00, which includes the \$50.00 civil fine set forth in the citation and a \$50.00 administrative fee. Payment shall be made to City of Hopkinsville, c/o Tax Office, 715 South Virginia Street, P.O. Box 707, Hopkinsville, KY 42240.


