

# **DOWNTOWN HOPKINSVILLE FARMERS MARKET PAVILION**

## **FEES**

1. There is a \$50.00 refundable fee for the clean-up of the Pavilion. If the Pavilion is left as it was found, the \$50.00 will be refunded. If any cleaning is required, a portion of the fee will be refunded depending on the cost to clean the Pavilion. Please make check payable to the Local Development Corporation.

## **SPACE ALLOCATION**

1. The use of the Farmers Market Pavilion at the corner of 9<sup>th</sup> Street and Bethel Street is only inclusive of the area under the Pavilion.
2. Parking is limited depending on the time of day of your event. During 8am-5pm Monday-Friday, there are tenants renting a portion of the parking lot. A diagram of the spaces will be provided.

## **ENFORCEMENT**

1. No tape is to be used on the concrete flooring, columns or rails of the Pavilion.
2. Please make sure all breakers are turned off except breaker #7 when you vacate the Pavilion.

## **SIGNAGE/BANNERS**

1. No signs, banners, or other advertising devices will be permitted without the prior, written consent of the Local Development Corporation. A representative of the Local Development Corporation must be able to view the proposed sign, banner, or advertising device prior to written permission being granted. All signs, banners, and advertising devices shall be professionally fabricated and any and all applicable permitting fees will be the sole responsibility of the individual or organization using the Pavilion. The placement of any and all signs, banners, and advertising devices will be subject to compliance with the Hopkinsville Zoning Ordinance.
